

LACLARE GOAT CHEESE FOR DAYS SWEEPSTAKES RULES

Enter online by submitting an entry form at: <https://recipes.laclarefamilycreamery.com/ngcm/>. Rules and details for the sweepstakes are described below.

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. **Eligibility:** Entrants must be 18 years of age or older as of the date of entry to enter the LACLARE GOAT CHEESE FOR DAYS SWEEPSTAKES a/k/a the Goat Cheese For Days Sweepstakes. The sweepstakes is only open to legal residents of the United States, with the exception of residents of the States of Hawaii and Alaska, and is void in Puerto Rico, U.S. territories and possessions, and where otherwise prohibited by law. Employees of LaClare Creamery, LLC and its affiliates, subsidiaries, advertising and promotion agencies, and suppliers, (collectively the “**Employees**”), and immediate family members and/or those living in the same household of Employees are not eligible to participate in the sweepstakes. No cash or other prize substitution shall be permitted except at the discretion of LaClare Creamery, LLC. The prize is nontransferable. Any and all prize-related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the Winner. No substitution of prize or transfer/assignment of prize to others or request for the cash equivalent by the Winner is permitted.
